#### 6. Project Update – questions were asked and answered throughout the presentation

GC provided an update on the community Support Program (CSP) including events and initiatives supported by MCO, along with upcoming events MCO are also supporting. AP asked if the Mudgee Museum had placed an application for the 2020 CSP, GC confirmed they had applied, however, were unsuccessful.

TC provided an operational update. DS asked why MCO were updating Environmental Management Plans. TC confirmed MCO undertake reviews annually and update the MOP to include the approved Environmental Management Plans.

TC provided an exploration update.

TC provided an update on environmental monitoring including water quality, air quality, noise and complaints. General discussion of water quality and level monitoring results, Rainfall Cumulative Deficit (RCD), operations and climatic conditions.

GC provided an employment update. AP asked how long the duration of the Skillset Land Management traineeships were. TC advised the duration of each traineeship can be different depending on training level and could be 18 months.

GC provided update on the UG4 Ancillary Works Modification

4. What was the groundwater make from UG1 to Jan 2020 plus post rains (ie most current water make).

UG1 dewatering is currently around 70lps, including water supply, inflows and recirculation.

5. Was there any groundwater extraction from water supply bores (Northern) or offsite discharge of excess water?

No recent extraction from the northern borefield.

6. Downstream landholders would like to be advised by MCO when mine water releases occur on the day of discharge.

MCO will advise the CCC when MCO is in a position to commence prior to water releases.

- Has the Drip walking track area been transferred into SCA?
   The walking track is maintained by NPWS within the State Conservation Area, within a NPWS easement.
- 8. After recent erosion event down Bobadeen Creek and loss of foot bridge would MCO consider installing conservation works (e.g. batter banks+ riparian plantings) along Bobadeen creek on

Bobadeen Station to help to stabilise banks and reduce turbidity levels downstream

A portion of the Bobadeen Creek is within the Bobadeen Offsets. Planting out and exclusion of stock will continue to be undertaken in the Bobadeen offsets. Approximately 2000 trees have been planted adjacent to Bobadeen Creek to date. The Bobadeen Offset will be progressively planted out including the riparian zones.

AP asked if MCO is currently being impacted by the Corona Virus (COVID19). SA confirmed MCO is proactively managing the impact of the COVID19 virus with site and corporate procedures. AP asked if there has been any impact on the shipping of MCO's coal. SA confirmed he was not aware of any impacts on the shipping of MCO's coal at this stage. DS discussed the use of NSW Health advice for managing the COVID19 virus at MCO. SA confirmed MCO would consider advice from NSW Health and other health authorities.



- Rehabilitation and monitoring activities have continued during the period.













# Water Quality - pH






# **Water Quality - EC**






# **Water Quality - TSS**






### **Groundwater - Level**

#### **HYDROGRAPHS - Palaeochannel and Alluvium**









# **Noise Monitoring**
